## 02/01/2018 KCRSPA Executive Committee Meeting

The minutes of the 11/02/2017 KRSPA Executive Committee meeting were read and approved.

Treasurer's Report: The balance as of 01/31/2018 is \$6783.68 The Scholarship Fund balance as of 01/31/2018 is \$5369.72. Of that amount, \$600 is in the Dr. Lorraine Costella Scholarship Fund.

## Old Business:

Jean Foreman asked permission to send \$50 to MRSPA for the Scholarship raffle to be conducted in May. We agreed that the money should be sent.

New Business:

Community Service – Billie Lynne Roberts sent in her report that Jean Foreman has been selected as our nominee for the MRSPA community service award. Billie Lynne has completed and mailed the application. A reference letter is needed for the MD Senior Citizen Award application. Carol Cordes has agreed to write the letter. Sue Crooks will finish and mail that application which is due April 10th. Congratulations to Jean for all of her services to others. There was some discussion about a general project such as maintenance of the Robert A. Crooks Memorial Garden at KCHS or starting "Little Free Libraries" in areas in the county where there is not a KCPL branch. Nancy Harrington will get us information about the "Little Free Libraries".

Scholarship – Billie Lynne reported that changes to the application form were made as discussed in the last executive meeting. The GPA suggested will be 3.0. The requirement that a student be part of the Teacher Academy was deleted. The edited application was delivered to KCHS in January by Terri Bostic.
