Thank you notes from Sawyer Cornelius and Ray Gill were read.

Legislative Chairman, Betty Barbe reported on Governor Hogan's attempt to put \$68 million that was intended for school systems into the "make-up" fund for the Maryland pension system. In a compromise with the legislature, Hogan agreed to give \$68 to the school systems as the General

Assembly originally intended and the legislature will put \$71 in the "make-up" fund for the Maryland pension system.

Ruth Wilson, Co-chairperson for Trips, reported that there were 2 seats open for the November 11, 2015 trip to Lancaster.

President Wheeler directed our attention to the issue of emeritus memberships for members over 90 years old. She asked for our written opinion about what should be done about the issue in view of the financial problems this policy is creating for MRSPA finances.

Dan gave a very informative presentation about the grant money KCPS has procured and all of the digital resources available to KCPS students including Discovery Education, digital textbooks, computers for students and district—wide licenses for services such as Google Docs and Gizmo.

Emily Massey, Hospitality Co-chairperson, conducted the 50-50 raffle drawing. \$31.00 was raised for the scholarship fund.

President Wheeler reminded us that KCRSPA has a website and that there will be a website training on November 17, 2015 at the Odenton office. Volunteers to help with the website are needed.

Legislative:

The following passage from the 10/01/15 Meetings of the General Meeting is corrected:

"Legislative Chairman, Betty Barbe reported on Governor Hogan's attempt to put \$68 million that was intended for school systems into the "make-up" fund for the Maryland pension system. In a compromise with the legislature, Hogan agreed to give \$68 to the school systems as the General Assembly originally intended and the legislature will put \$71 in the "make-up" fund for the Maryland pension system."

The correction is as follows:

"It was proposed by the Maryland General Assembly that if Gov. Hogan would agree to give the \$68 million GCEI funds to the school systems as originally intended by the legislature, then the Maryland legislature would put \$71 million in the pension make-up fund." Please note that as of the date of the 10/01/15 general meeting, the agreement had not been finalized. It had been proposed.
