Minutes from the September 7, 2017 KCRSPA Executive Committee Meeting

The meeting was opened with the Pledge of Allegiance at 10 am at the Kent County Public Library Annex Building.

Minutes: The minutes were read and approved.

Treasurer's Report: Treasurer Jean Foreman reported that there is a balance of \$7312.24 as of 09/01/17. The scholarship fund balance is \$3477.65. Of that balance, \$100 is part of the Lorraine Costella Scholarship Fund. Jean Foreman also presented the 2017 – 2018 budget which was \$10,065 income and \$10,065 expenses.

The Maryland Senior Citizen Hall of Fame Annual Awards Luncheon will be held on Thursday, October 26, 2017 at 11 am. The cost for a reservation is \$23. Betty Barbe from KCRSPA will be awarded membership in the Maryland Senior Citizen Hall of Fame at this meeting. We hope that many of us will be able to attend to enjoy the day with Betty. Cliff School: Jean Foreman reported that the Kent County Commissioners have authorized the county grounds crew to provide upkeep of the grounds of Cliffs School. She reported that, as a result, the Cliffs School property looks beautiful. Ken Milton has almost finished the blackboards and his area is cleaned up. There may be a fundraiser this fall. Ralph Dowling, President of Peoples Bank, is working on this.

Terri Bostic, who attended the Kent County Commissioners meeting when County ownership was considered, reported that Kent County will not take ownership of the property, but will consider fund requests in the future. Kathy Clark asked if there was a written commitment from the commissioners to help with upkeep.

Nancy Harrington volunteered to help thin out the lilac bushes on the Cliffs School property. Kathy Clark volunteered to bring the tri-fold display about Kent County small schoolhouses to Cliffs School for display.
