The modern SULTANA sails as a school ship, taking more than 4,500 students out onto the Chesapeake Bay each year for hands-on programs in environmental science and history. SULTANA sails with school systems around the Chesapeake, regularly sailing from ports including Chestertown, Annapolis, Baltimore, St. Michaels, Cambridge, Oxford, Solomons, and Crisfield.

Each year the Sultana Education Foundation (SEF) helps more than 10,000 students experience the Chesapeake Bay and learn what they can do to restore North America's largest estuary. SEF's school programs complement existing classroom curricula and help participating schools fulfill their Environmental Literacy program requirements. Many of SEF's core programs are certified by the Maryland State Department of Education.

Gunston frequently uses this great resource in their Bay Studies Week program. And I took my photography students to the work yard to take photos during the construction. The Sultana is a valuable addition to education in Kent County.

I was hesitant to cancel the March General Meeting, but at the time the decision had to be made the numbers weren't looking good. ***Treasurer Debbie Smith** reported our ending balance as of Jan. 31, 2022 is \$8923.62. The scholarship fund balance as of Jan. 31 is \$3798.17, which includes \$500 in the Dr. Costella scholarship fund.

Approval of the report was moved and seconded by Betty Weller and Brenda Shorter respectively.

***Pres. Report:**

Due to Covid surge and reticence on the part of membership, an executive decision was made to cancel the March luncheon.

For future executive committee meetings, members will be notified/reminded by emails or phone calls due to the unreliability of the mail.

A motion was passed to have the scholarship committee send "thank you" notes to all who donate to the fund.

Fay is still working on the tax number problem in order to make the contributions tax deductible.

***Community Service: Nancy Harrington** - We now have "Little Libraries" in several places in the county: Worton Park, Rock Hall, and Tolchester. KCRSPA received a major donation of used books from Galena Elementary School, where the librarian is cleaning out and reorganizing.
