

Becky Glen mentioned a young writer of books from Rock Hall who will regale us with her notes on how she became a writer of children's books.



Dr. Raymond E Clarke was the first administrator to greet me and introduced himself to me on my arrival in Kent County in 1985. I found him to be a great coworker for the nine years when we worked together. However, he was even a greater friend for the 40 years that we knew each other.

He was extremely qualified and certified for the position he held. More importantly, his professionalism was such that it was noted by all, and his suggestions, ideas, and recommendations were always well received. His assignments were neat, timely and well prepared and relative to the subjects being discussed.

He also used his professionalism with various statewide associations. Ray was president of the Middle School Principals Association of Maryland and the Maryland Association for Supervision and Curriculum Development. He also served on the board of the Maryland Association of School Principals.

Locally he served as President of the Kent County Retired School Personnel Association, where he received a statewide award for the KCRSPA for his community service.

He VOLUNTEERED at MOST CHARITABLE ORGANIZATIONS IN THE COMMUNITY. And was well known for his generosity.

Ray liked playing golf with his friends at Chester River Yacht and Country Club and especially traveling with other educators on golfing outings to Myrtle Beach, South Carolina, Pinehurst and Fayetteville, North Carolina.

Ray also participated in many Elks Club activities and served as Exalted Ruler of the local lodge. He took advantage of the many facilities of various Elk Lodges throughout the country.

Always amusing, Ray frequently was trying to tell silly jokes, especially with his New England accent.

The Kent County Public School system lost a dedicated educator when Ray retired and now the community has lost a very kind and caring person.
