#### 06/04/15 KCRSPA General Meeting Minutes

The meeting was called to order by President Nancy Harrington at 11:22 at Luisa's Restaurant in Chestertown, MD.

Nancy welcomed our guests: Max Muller, President of MRSPA; Judith Zahren, Executive Director of MRSPA; and Flo Terrell 2014-2015 KC Teacher of the Year.

Two of our members who have recently passed away, Doris Lill and Sue Quinn, were remembered and honored by the presentation of individual roses.

Committee Reports:

Cliff School:

Jean Foreman asked for volunteer docents for Cliff School and for volunteers to sell chances on an "Italian Basket" at the Farmers Market in Chestertown on July 18, 2015. Proceeds will go to Cliff School.

#### Scholarship:

Billie Lynne Roberts reported that KCRSPA awarded 4 scholarships for \$1000 each this year. The recipients were Casey Roberts, Savanah Hague, Ray Gill, and Sawyer Cornelius.

#### Service:

Billie Lynne Roberts asked that we keep a record of our service to the community.

#### Membership

Fay Miller visited 5 schools to invite people who are retiring to become members. We had a 6.02% increase in membership this year and received Honorable Mention for membership growth at the MRSPA Annual Meeting in May.

#### Legislative:

Betty Barbe reported. The Administration through the Speaker of the House has introduced legislation supporting Charter Schools - The Public Charter School Expansion and Improvement Act. MRSPA recommended opposing this legislation with a letter.

There was legislation which replaced "corridor funding" of state pensions with an "actuarial" method. "Corridor funding" was adopted under the Glendenning administration and resulted in years of insufficient state contributions to the pension fund. The O'Malley administration pledged to reinvest money back into the system with the goal of restoring it to 80% funding by 2023 and to 100% funding by 2038. Unfortunately, legislators siphoned off some of this money that was intended to restore the integrity of the pension to balance the state books. That happened 2 years in a row. Because of recent strong stock market performance, an immediate shift back to full actuarial funding has been recommended by the Department of Legislative Services. The extra "make-up" payments used under "corridor funding" would be abandoned.

Gov. Hogan recently pulled \$68 million from education appropriations and used some of that money to contribute to the state pension as part of the "make-up" money that started under the O'Malley Administration. These funds were badly needed by the school systems to prevent teacher lay-offs and programs for the students, including pre-K programs. The districts most hurt by the diversion of education funds were Baltimore City, PG County and Montgomery County, but the schools systems of all counties will be affected. Please note that the state's required \$1.8 billion pension contribution was made this year and that the pension funds are safe from any "raiding" by the legislature or the governor. The funds in question are those that were supposed to be contributed in addition to the required funding since the shortfall caused by "corridor funding" under Gov. Glendenning. There are assertions that this denial of funds to the school districts and the diversion of those funds to the pension system are illegal actions.

There has been a commission established to study testing and assessments.

There has been a commission established to study pre-school.

Our guest speaker, Flo Terrell, spoke about her experiences as the Kent County Teacher of the Year.

MRSPA Max Muller spoke about the importance of membership. Numbers are important as we go into Annapolis to protect our pensions.

MRSPA Executive Director Judith Zahren spoke about her experiences with KCRSPA.

MRSPA President-elect Fay Miller reminded us that this year's theme is "The best is yet to come." She congratulated KCRSPA on reaching its 50<sup>th</sup> anniversary and commented that our pension is secure at present, but we must always pay attention to what the state government is doing regarding the pension and other funding since our health benefits are funded by Kent County and cuts in state funding could affect the county's ability to fund our insurance.

Incoming President, Dr. Barbara Wheeler greeted the members. She made positive comments about the Cliff School. She said that if any of us wants to be a chairperson or co-chairperson of a committee, we should contact her.

The minutes of the May 7, 2015 Executive Committee Meeting were read and approved.

This proved to be illegal and now, according to the <u>Action Line</u>, Gov. Hogan has "carted it off" where it will sit until a year from now when it can be used by the Governor "for anything he pleases".

Betty encouraged us to visit "marylandeducators.org/2015Scorecard" for a regional guide to your legislators' education votes.

This year's MRSPA Legislative Workshop will be held on November 4 in Annapolis.

#### Membership

The MRSPA has set its goal at 15,000 members by March 1, 2016 and is asking each local to increase its membership by 7%, which for us could be as few as 2 new unified members. Fay has been very active in contacting potential members including new retirees, who will be welcomed at the Oct. 1 meeting Fay reported that the Emeritus Membership issue will continue to be explored and will be a topic of discussion at the upcoming legislative workshops.

# 48-star flag given to Cliffs School

**CHESTERTOWN** — To make certain the artifacts in the Cliffs School Museum are as authentic as possible, the Port of Chester Questers have been successful in procuring a classroom-sized flag with 48 stars, in keeping with the years the schoolhouse was open.

Shelby Strudwick, a Kent County resident, recently donated the 60-year-old flag.

The Cliffs School Museum is a one-room schoolhouse which served children in grades one through seven for Kent County's farming and watermen communities. It opened in 1878 and closed in 1939. President Dwight town, on the the third month the vate show call 410-7' rangemer welcome.

**CHESTERTOWN** — To make certain the artifacts in the Cliffs School Museum are as authentic as possible, the D. Eisenhower signed statehood bills for the 49th and 50th states (Alaska and Hawaii) in 1959.

In the schoolhouse, lessons of the day for each class are written on the blackboards. A pot-bellied stove — used for heat and to warm soup for lunch, student desks and textbooks are also on view.

The schoolhouse is located 8.5 miles south of Chestertown, on Quaker Neck Road. It is open to the public on the third Saturday of each month through October. Private showings are available; call 410-778-2529 to make arrangements. Donations are welcome.



# Make Barista Worthy Iced Coffee at

### Huge Savings

To make: Combine 6 ounces (1 1/2 heaping cups) medium to coarsely ground coffee with 4 cups roomtemperature water in a glass container. Let sit at room temperature for 12 hours.

Strain through a mesh strainer lined with a coffee filter. (This base, about 2 3/4 cups total, will keep in the refrigerator for 2 weeks.)

To serve: Combine a scant 1/2 cup of the coffee base with equal parts of water and milk. Pour over ice. Makes 6 servings.
