Any time you have a problem with physician acceptance of your insurance, or questions regarding a bill that normally would be covered, contact **RETIREEFIRST 1-855-236-7152**. The number will take you to RetireeFirst. You will be answered by a person on the staff and she/he will hear your problem. This is for all questions or problems with acceptance of bills.

It would be handy to put this number - **855-236-7152** on your cell phone. If the physician you are seeing will not accept your insurance, you can contact RetireeFirst while you're at the doctor's office and the RetireeFirst people will try to work with the physician.
